### 2-3-5 Collection Limited Warranty Agreement

#### TAJ 2mm/12mil Wear Layer Luxury Vinyl Planks and Tiles

This is a legal contract between \_\_\_\_\_ and TAJ Flooring, Inc.

TAJ Flooring, Inc. warrants that the wear layer of the TAJ floor coverings shall be free from defects in material and workmanship for fifteen (15) years from the date of sale, and will not wear through the wear layer, provided such floor coverings are subject to normal use in residential traffic applications such as within the units of multi-family dwellings, hotel rooms, or senior living units and that the product receives regular and proper maintenance. This warranty will become null and void if conditions of the substrate and the installation method do not conform exactly to TAJ Flooring's recommendations.

Note: TAJ offers this product as a wall covering solution. The TAJ Specialty Wall Adhesive for LVT is required for wall installations to be covered by this warranty.

This warranty does not cover damage caused, in whole or part, by conditions beyond our control, including but not limited to:
